GIVEAWAY PERIOD

The Spot the Medal Giveaway (the "Giveaway") begins at 7:00 a.m. Eastern Time ("ET") on Friday, February 9, 2018 and ends at 11:59 pm ET on February 25, 2018. (the "Giveaway Period"). Mailed entries must be postmarked by Monday, February 26, 2018.

ELIGIBILITY

The Giveaway is open only to legal residents of the United States who reside in the state of Virginia and who are eighteen (18) years of age or older at the time of entry (the "Entrant" or "Entrants"). Employees, contractors and interns of GateHouse Media, LLC and Gatehouse Media Virginia Holdings, Inc. d/b/a The Progress-Index (together, "GateHouse Media"), and each of their respective divisions, affiliates, parent companies, subsidiaries, advertising and promotion agencies (including, in each case, immediate family members) are not eligible to enter the Giveaway.
